In order for NORNA PLAYGROUNDS to be FSC®-certified as a company and factory, it requires that:

- We can present comprehensive documentation.
- Our employees are trained in handling FSC®-certified wood.
- We are inspected by an impartial certification company.

FSC® (Forest Stewardship Council®) is an international marking scheme for sustainable wood

The FSC® mark documents that the products stem from forest areas that are used sustainably.

Behind the FSC mark, there is a strict international control system. The FSC® system ensures and monitors that the wood can be traced back to the forests from where it originates.

In order for NORNA PLAYGROUNDS to be FSC® certified as a company, it requires that we can present comprehensive documentation and that our employees are trained in handling FSC®-certified wood. Furthermore, all companies or forests with a certification are subject to an annual inspection by an impartial certification company.

NORNA PLAYGROUNDS is a Danish manufacturer of playground equipment made of Robinia wood, which supplies sustainably-produced playgrounds to its customers thanks to its FSC® certification

- The FSC® ensures that the number of trees chopped down does not exceed what the forest can replenish naturally.
- The FSC® ensures that rare plants, waterways and springs are protected.
- The FSC forest ensures that endangered animals are safe by protecting their habitat from logging.
- FSC® protects local populations, forest workers and natives of forests across the world.
- The FSC® ensures that a percentage of the total revenue from the forest is used to support the local society.
- The FSC® makes sure that forest workers receive a fair salary, safety equipment and training.

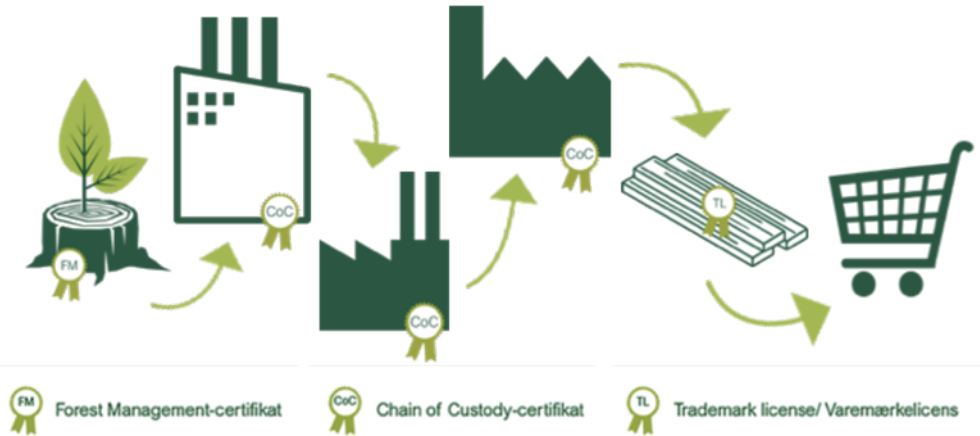
Playground equipment is typically not marked with an FSC® logo

At the same time, rare plants, waterways and springs are protected. The forest's drinking water and waterways thus retain their natural form and are protected from pollution.

FSC®-certified forests are considerate and beneficial towards the environment, climate, animals and plants.

In an FSC® forest, endangered animals live safe lives because the areas they live in are protected against logging.

SMART PACKING is sustainable, smart and easy

The way we pack and deliver our playground equipment makes it easy, smart and sustainable to receive playground equipment from NORNA PLAYGROUNDS. We can do this because our equipment is pre-drilled with SMART ROBINIA®. This means that:

- The shipment is split up and packed in smaller units. This allows us to deliver the products to otherwise inaccessible places. The products can, if necessary, be carried component by component through narrow passages.
- The playgrounds can be shipped as ordinary goods and sent together with other products. More in the vehicle – better for the environment.
- Each individual product is clearly marked with steel band. This makes it easy to spread out the equipment at the location and thus get a good overview before installation.
- We have also reduced the amount of plastic and packaging. When we pack, we use recycled cardboard as much as possible.
